- Tranche 3 (Sept to Nov): Aberdeen, Dundee, Inverclyde, Moray, South Ayrshire, South Lanarkshire and West Lothian Councils -(17 Jobcentres)
- Tranche 4 (Dec to Apr): Angus, Argyle& Bute, East Ayrshire, East Dunbartonshire, Fife and Perth &Kinross Councils – (20 Jobcentres)

## The Digital Service (DS)

- Make Scalable DS extended from Sutton JC to 7 other Jobcentres across the country (Spring 2016)
- Transition –Roll out of DS to Jobcentres. Claims from Families taken from this point. No new claims to the 6 benefits that are being replaced by UC in these locations from go-live date (Summer 2016 – 2018)
- Transfers Current live UC claims will transfer to the DS, in the 3-month period following go-live.
- Natural Migration change of circumstances that would have led to a claim for another benefit (e.g. JSA claimant goes sick) the claimant will instead claim UC
- Managed Migration at end of Transition period the movement of residual legacy claimants to UC (2018-2020)
